Policy on the Explanation of Shareholding Status

Sumitomo Mitsui DS Asset Management Company, Limited (hereinafter "SMDAM") accepts the Principles for Responsible Institutional Investors «Japan's Stewardship Code» and, upon request from investee companies, will endeavor to explain our shareholding status to the extent that it contributes to constructive dialogue with them.

1. Policy

- I. Disclosable Shareholding StatusThe scope and reference date of the disclosable shareholding status are as follows:
 - A) SMDAM's shareholding ratio in the relevant investee company (to one decimal place), calculated based on the method for determining the Holding Ratio of Share Certificates, etc. under Article 27-23, Paragraph 4 of the Financial Instruments and Exchange Act (or the Large Shareholding Reporting System).
 - B) The shareholding ratio as of the reference date requested by the inquirer.

II. Timeframe for Response

- A) For inquiries received between the first and last day of a month, SMDAM will respond within 10 business days of the following month. In the event of a delay, SMDAM will contact the inquirer individually.
- B) Responses will be sent by email in principle. Please note that emails may fail to be sent or received due to technical issues. If you do not receive a communication from SMDAM within the aforementioned period, please contact the Stewardship Development Department at stewardship@smd-am.co.jp.
- III. Frequency of Inquiries
 Inquiries are limited to once per company per quarter.

IV. Verification of the Inquirer's Identity

- A) SMDAM will verify the history of contact between SMDAM and the investee company to which the inquirer belongs.
- B) In some cases, SMDAM may make a phone call or other contact to the main representative of the investee company to which the inquirer belongs.

V. Other Notes on Inquiries

- A) When making an inquiry, please provide the following information: details of your company (company name, stock code), an email address for communication regarding the shareholding status, and your information (department, name).
- B) Inquiries are limited to investee companies.
- C) The information on SMDAM's shareholding status is for the use of the investee company only. Sharing it with or providing it to third parties is not permitted.
- D) Please note that SMDAM may be unable to respond if it cannot verify the inquirer's identity.
- E) SMDAM will not provide explanations of shareholding status for specific accounts or strategies.
- F) SMDAM cannot explain shareholding status by the number of shares.
