

## Results of Exercise of Proxy Voting Rights at general meetings from July to September 2021

To appropriately deal with conflicts of interest and enhance the visibility of its exercise of voting rights, Sumitomo Mitsui DS Asset Management (SMDAM) will individually disclose voting results of all proposals for which it exercises voting rights it holds in investee companies and investment corporations.

From the perspective of responding to concerns about conflicts of interests,

- (i) in its exercise of voting rights on all proposals of its major shareholders including Sumitomo Mitsui Financial Group, Daiwa Securities Group, and MS&AD Insurance Group Holdings, SMDAM will vote in favor of resolutions only when recommendations of external advisory bodies and SMDAM standards indicate both in favor; and
- (ii) as a general rule, for resolutions regarding the appointment of directors and auditors who were either employees/officers of SMDAM or CEOs/Representative Directors of SMDAM's major shareholders, SMDAM will vote in favor of those resolutions only when recommendations of external advisory bodies and SMDAM standards indicate both in favor.

The number of resolutions for which voting rights were exercised at general shareholders meetings held from July to September 2021 was 1,393 for company-proposed resolutions and 0 for shareholder-proposed resolutions. With regard to the types of resolutions, "Appointment and dismissal of directors" was the largest in number at 1,059, followed by "Appropriation of retained earnings" at 96, "Executive compensation" at 72, "Appointment and dismissal of auditors" at 69, and "Partial amendment of the articles of incorporation" at 56.

In light of ["Criteria for Determining the Exercise of Voting Rights"](#) and ["Current policy and future direction on the exercise of voting rights in Japanese equities"](#), SMDAM judged all resolutions, the objection rate of which resulted in 21.8% for company-proposed resolutions. With regard to the types of resolutions, the objection rate was 22.9% for "Appointment and dismissal of directors," 8.3% for "Appropriation of retained earnings," 22.2% for "Executive compensation," 33.3% for "Appointment and dismissal of auditors," and 1.8% for "Partial amendment of the articles of incorporation."

The number of resolutions for which voting rights were exercised at general investors' meetings held from July to September 2021 was 62 for corporation-proposed resolutions and 0 for unitholder-proposed resolutions. With regard to the types of resolutions, "Appointment and dismissal of supervisory officers" was the largest in number at 30, followed by "Appointment and dismissal of executive officers" at 21, and "Changes to the articles of incorporation" at 11.

In light of ["Criteria for Determining the Exercise of Voting Rights"](#) SMDAM judged all resolutions, the objection rate of which resulted in 37.1% for corporation-proposed resolutions. With regard to the types of resolutions, the objection rate was 10.0% for "Appointment and dismissal of supervisory officers," 90.5% for "Appointment and dismissal of executive officers," and 9.1% for "Changes to the articles of incorporation."

SMDAM discloses the reasons for its objection to each resolution of both investee companies (domestic stocks) and investment corporations (J-REITs), or the main reasons in cases where there are multiple reasons for objection. SMDAM judges "approval" or "objection" based on its ["Criteria for Determining the Exercise of Voting Rights"](#).

SMDAM formulates and discloses ["Criteria for Determining the Exercise of Voting Rights"](#) to eliminate arbitrariness as much as possible and to realize appropriate corporate governance. SMDAM will continually review these standards in response to changes in the external environment or engagements with investee companies/investment corporations, etc., and will strengthen its efforts to increase corporate value through the exercise of voting rights and active dialogue with investee companies/investment corporations.
