- (i) in its exercise of voting rights on all proposals of its major shareholders including Sumitomo Mitsui Financial Group, Daiwa Securities Group, and MS&AD Insurance Group Holdings, SMDAM will vote in favor of resolutions only when recommendations of external advisory bodies and SMDAM standards indicate both in favor; and
- (ii) as a general rule, for resolutions regarding the appointment of directors and auditors who were either employees/officers of SMDAM or CEOs/Representative Directors of SMDAM's major shareholders, SMDAM will vote in favor of those resolutions only when recommendations of external advisory bodies and SMDAM standards indicate both in favor.

SMDAM discloses the reasons for its objection to each resolution of both investee companies (domestic stocks) and investment corporations (J-REITS), or the main reasons in cases where there are multiple reasons for objection. SMDAM judges "approval" or "objection" based on its "Criteria for Determining the Exercise of Voting Rights".

SMDAM formulates and discloses "Criteria for Determining the Exercise of Voting Rights" to eliminate arbitrariness as much as possible and to realize appropriate corporate governance. SMDAM will continually review these standards in response to changes in the external environment or engagements with investee companies/investment corporations, etc., and will strengthen its efforts to increase corporate value through the exercise of voting rights and active dialogue with investee companies/investment corporations.

[Proposals requiring explanation]

This is to provide a supplementary explanation for proposals that cannot be described in the one-line comments in the exercise results list in the attached PDF file because they have a strong qualitative element and do not conform to simple formal criteria. SMDAM strives to disclose its standards of judgment through explanations of proposals that have attracted attention, such as the rejection of management proposals and the passage of shareholder proposals.

At the July to September 2023 meeting, SMDAM considers the following proposals to be particularly requiring explanation:

3391 TSURUHA HOLDINGS (Shareholder Proposal)

TSURUHA HOLDINGS received shareholder proposals to improve transparency in governance. We agree that TSURUHA's governance has transparency issues. However, we voted for TSURUHA's management proposal for two reasons. (1) TSURUHA is eager to make quick decisions, including industry restructuring, and to strengthen its governance for this purpose. (2) There is uncertainty as to whether the Shareholder Proposal Candidate will contribute to the rapid formulation of strategies, including industry restructuring. The Management Candidates may be quicker to strengthen governance than the Shareholder Proposal Candidates. As an investor, we need to continue to monitor the governance of TSURUHA.

3549 KUSURI NO AOKI HOLDINGS (Shareholder Proposal)

KUSURI NO AOKI HOLDINGS received several shareholder proposals to strengthen its corporate governance. We voted on each shareholder proposal as follows.

- Mr. Ikei in Proposal No. 4 (Election of Directors): SMDAM compared Mr. Ikei with Mr. Fujii in Proposal No. 2-10 and voted for the shareholder proposal because it was possible to evaluate Mr. Ikei from the perspective of independence.
- Proposal No. 5 (Election of a Lead Independent Director): We considered that requesting the election of an outside director with the independence standards of the TSE was consistent with SMDAM's voting criterion. We voted for the shareholder proposal because the lead independent outside director is expected to improve the effectiveness of independent directors, improve their engagement with investors, and increase its corporate value through these initiatives.
- Proposal No. 6 (Establishment of a Nomination and Compensation Committee): Although there were concerns that the amendments to the Articles of Incorporation may be too detail and restrict its business, we voted for the shareholder proposal because the company does not currently have a voluntary Nominating and Compensation Committee.

Proposals 7 and 8: We voted for the shareholder proposal as we consider that the compensation for outside directors was not excessive. With regard to the restricted stock compensation in Proposal No.
 8, although there is no limit on the maximum number of shares, it is limited to the maximum amount. Given the company's stock price over the past several years, we believe that the proportion of the shares to the total number of shares outstanding is small.
